### **Open Positions**

**Treasurer** - The treasurer shall be responsible for all the finances of club. He/she will see that accurate and readily interpretable records of all income and expenses are maintained. A written financial record will be distributed to Board members at each meeting.

**Secretary** - The Secretary shall be responsible for keeping the minutes of the club meetings and club records as well as administrative duties. The Secretary will also be responsible for all communication within the club.
